

## March 12, 2026 – Quarterly Member Meeting



### Opening

- The meeting of the Tennessee Region SCCA was called to order at 7:03 PM by MD
- 11 Participants
- Meeting was virtual

### Regional Executive's Report [Mike Donovan]

- This is our first Quarterly Public Member meeting
  - Monthly Board Meetings are going well (first Thursday of the month)
- Total TN Region SCCA Members as of January 2026: 508 – Large Region Designation
- 47 weekend members in 2025, conversion rate is 4 per year
- Entry Fees update
  - 2025 SCCA fee was \$14.25 per driver, in 2026 increasing to \$16.50 per driver (+\$2.25)
  - Weekend membership fee increasing from \$15 to \$20 each
  - 2026 site cost increase at NSS +\$300
- Course Designers must take Solo Course Design Class for license. Reach out to Solo Chair if you're interested.
- Equipment purchased – 50 orange and 20 green cones, second timing display to be put on trailer, new trailer jack, new hats and hoodies, small heater for trailer, sound meter, schedule banners for trailer and C&C, helmet cabinet.
- \$10 late registration fee for walk up registrations to encourage early sign-ups, so we can prepare heats/workers earlier.
- Logan and Court went to SEDiv SCCA Convention, great networking with our neighbors and learned how we stack up against other regions.

### Solo Event Chair Report [Logan Altmeyer]

- TNT – NSS 3/8/2026
  - 74 drivers, ~8 runs on average. Maximum of 14 by 3 drivers
  - No big issues, everything functioned as expected
- PE1 – Music City Raceway 4/12/2026
  - Tim to be course Designer
  - Currently 10 signed up on MSR. Registration closes 4/10 Friday at Noon
- Reminder: TRSCCA membership required to win end of year championship
- C&C reached out to request us to move June 13th event to June 6th or 7th. Discussing with track currently to ensure we can stay in C&C lot.
